THIS IS A LEGAL AGREEMENT, by accessing, downloading, or using the House Industries Webfonts you expressly agree to the following terms and conditions:

1. This License is for the benefit of those users authorized under this Agreement who are downloading the House Industries Web Font software ("Fonts," or "Web Fonts," or collectively, the "HIWF"). This license does not permit the downloading and use of the HIWF (also, the "Font Software" or "Web Font Software") for use on a desktops, laptops or workstations; if you wish to use the HIWF in such a manner you must secure a separate license and use the House Industries Font Software created for use on personal computers and such related devices as are permitted under those licenses. If you will be re-serving the Font Software for use on the websites of third parties or otherwise making the Font Software available for use by others, irrespective of the methods or technology used, you are required to purchase additional licenses. You further agree to treat the Font Software as confidential information and exercise reasonable care to avoid unauthorized distribution of the HIWF. This non-exclusive, revocable license grants you limited rights to use the Font Software for the viewing of type faces on websites only. Other restrictions may apply. All other rights, title and interest in and to the Font Software, the design of the Fonts embodied therein, the trademarks, trade names and service marks are each the exclusive property of House Industries.

2. The HIWF is licensed on a per domain basis. For the purposes of clarity, you may purchase a license to use the Web Font Software with only one internet domain name and one website. Use of the Web Font Software on more than one domain/website requires the purchase of an upgraded HIWF. Irrespective of the license(s) purchased, the licensee must, at all times during the licensing term, remain in your exclusive and actual control during the use, serving, display and transmission of the Web Font Software.

3. Except as may be otherwise expressly permitted herein or in a separate written agreement, you may not modify, adapt, translate, reverse engineer, decompile, disassemble, alter, re-serve or otherwise copy the HIWF or the designs embodied therein. You may not serve or re-serve the HIWF to third parties or websites that are not permitted under your particular license unless otherwise expressly licensed by House Industries. 4. If you are using the Font Software for the creation of a third party websites, unless specifically licensed for such actions, such as a multi-domain or other express written

license permitting such actions, the user displaying the House Industries Fonts must purchase a HIWF License. If you have purchased a license to use non-Web Font House Industries Font Software, you do not have a right to transmit, serve or otherwise deliver or re-serve the Font Software digitally or physically either for yourself or for the benefit of any third party. No ownership rights or implied licensing rights are granted under this License

5. You agree that the creation of any derivative designs or type face font software is expressly prohibited under this License. Any derivative work which uses incorporates or is otherwise based upon the design of HIWF or any of the House Industries Font Software, including, but not limited to software, EPS files, artwork designs or other electronic works, are considered derivative works and shall be the exclusive property of House Industries. House Industries shall not be responsible or liable for unauthorized, modified and/or regenerated software or derivative works.

6. The HIWF License is licensed based upon a one time license fee and is available from House Industries or its authorized providers of such web font software. Use of the Font Software in font serving and/or replacement on websites or serving to websites, is permitted, as expressly identified under this Agreement. If the HIWF License is terminated, you are not permitted to copy, store or archive the Web Font Software for any purposes whatsoever. No implied license or right to use the HIWF exists under this License and none shall be construed. The failure to make payments for the HIWF or any associated services will result in the termination of this License together with any associated services. You are not permitted to redirect or permit "hot linking" or re-serve the HIWF. The HIWF License granted herein is specific to you and the website(s) identified in your License Agreement and may only be used for legal purposes and cannot be transferred, loaned, sold or assigned. You may not store or cache the HIWF, except as may temporarily occur during proper use of the HIWF. All rights not expressly identified and granted as a part of the HIWF or any related services are expressly reserved to House Industries.

7. If you are a designer, an advertising agency, acting on behalf of an advertising agency or otherwise acting in a similar capacity or for the benefit of a third party and your uses of HIWF will not be under your constant and exclusive control and/or exceed the number of domains/websites licensed under your License, the purchase of additional or an upgraded HIWF License is required and, depending upon the nature and character of the uses of the HIWF, an additional license upgrade and/or the purchase of an additional special license may be also be required. If you are creating works that require access of the Web Font Software by an unlicensed third party, the end using party is required to purchase a HIWF License. 11. You are permitted to transfer this HIWF License provided you notify House Industries of both the transfer and the new domain/website address upon which the Web Font Software will be used. House Industries shall have no responsibility for errors associated with incorrect information related to the transfer of the license or issues related to services associated with the Internet address or website of the party accepting the transferred HIWF License.
